



## Scale of Fees for Overseas Students

The Caulfield Grammar School Council has approved the following Scale of Fees for 2027.

**Application for Enrolment Fee:** a non-refundable and non-transferable fee of \$255, which is payable upon submission by a parent or legal guardian of an application to enroll their child at the School.

**Confirmation of Enrolment Fee:** a non-refundable and non-transferable fee payable in respect of each student, comprising the \$1,250 Enrolment Fee and a 50% prepayment of the Annual Total Fee and including Boarding Fees where applicable.

Caulfield Grammar School's Annual Total Fee for students from overseas includes the following:

- An Annual Tuition Fee;
- A State Payroll Tax Surcharge covering the cost of compulsory State Payroll Tax and Levies. This charge or portion of the charge is non-refundable and non-transferable and is subject to change for increases or decreases in State Payroll Tax and/or Levies;
- An Additional Fee covering compulsory government medical insurance and the Year Level Consolidated Charge. The Year Level Consolidated Charge covers compulsory year-level extras, including class-set books and materials, films, camps, prescribed excursions and incursions, specified technology resources (excluding iPads, laptops or equivalent devices for Years 7–12), access to services, and the special activities program fee.

The following additional charges may apply:

- Boarding Fees, if applicable; and
- At Year 9 an additional charge for the Year 9 Outdoor Education Experience (Kakadu).

Caulfield Grammar School fees exclude costs for:

- Uniforms;
- Books and stationery included in the year level booklists;
- Individually prescribed iPads, laptops or equivalent devices from years 7 – 12;
- Accommodation for day students;
- Transport to and from the School;
- Any courses or optional programs taken outside the School.

Please note the following:

- Other information must be provided upon request in accordance with the requirements of the Department of Education and Training.
- Please refer to the School's refund policy in the Terms and Conditions. This notice does not affect the student's right to take further action under Australian Consumer Law.
- The School's grievance resolution processes do not limit the student's right to pursue other legal remedies.

## Rendering of Accounts

For 2027, Tuition Fees, Boarding Fees, State Payroll Tax Surcharge and Additional Fees for Caulfield Grammar School (the School) will be rendered in October of each year.

All fees, charges and surcharges are payable within 14 days of the account being rendered. Parents may elect to pay the fees, charges and surcharges set out in the Scale of Fees table above by one of the following methods, as detailed below: (1) two instalments, (2) monthly instalments or (3) a lump sum. Payments will be applied first to the oldest outstanding balance. Accounts for additional fees —including but not limited to music charges, bus fees and optional programs, etc.— may be rendered periodically throughout the year and are payable within 14 days of being rendered.

To minimise administration costs and transaction fees, the School does not accept payments by cash, cheque or credit card. Application and enrolment fees may, however, be paid through the School's merchant facilities. The School's preferred payment method is BPAY. A payment declined by a financial institution for any reason may incur a \$50 administration fee.

## Two instalment payment option

The School standard payment option is three instalments being payable in October and April of each year.

## Monthly instalment payment option

For Parents with an Australian Bank Account the School offers a nine-month instalment payment option, with consecutive monthly payments from October to June inclusive. To use this option, parents must register and authorise direct debits through the Veracross Payment Gateway. A direct debit declined by a financial institution for any reason may incur a \$50 administration fee.

## GST

Currently school fees are GST free.

## Building Fund

The School maintains an active building program at each campus, and to enable parents to contribute to this program there is an opportunity for a voluntary contribution to be issued through the School's billing system. Donations to the School's Building Fund are tax deductible and a receipt will be forwarded in July each year.

## Optional programs and services

Optional programs and services outside the curriculum are available for an additional fee. These may include, but are not limited to, private music and instrumental tuition, bus services and other activities, etc. Accounts for these programs and services are generally rendered at the end of each term.
